## **NOTICE TO ALL MEMBERS OF THE BRICK AND ALLIED CRAFT UNION OF CANADA, LOCAL 31**

In January 2023, a meeting was held at which members of the Brick and Allied Craft Union of Canada, Local 2 (“BACU Local 2”) and Brick and Allied Craft Union of Canada, Local 31 (“BACU Local 31”) voted on a proposed merger of the two unions. The vote results were strongly in favour of the merger proceeding.

In June 2023, BACU Local 2 filed an Application for Declaration Concerning Status of Successor Trade Union (the “Application”) with the Ontario Labour Relations Board (the “Labour Board”). In this Application, BACU Local 2 requests the Labour Board declare under section 68 of the *Labour Relations Act, 1995* that BACU Local 2 has acquired, by reason of a merger, the rights, privileges and duties under the *Labour Relations Act, 1995* of its predecessor, BACU Local 31.

As a member of the BACU Local 31 and someone who may be affected by the Application, you are entitled to notice of the Application and must be provided an opportunity to file any submissions you believe are relevant to the Labour Board’s consideration of the matter. This document serves as that notice.
